#### What To Do If You Suspect Nursing Home Abuse/Neglect?

After transitioning someone you love to the care of a Nursing Home, ensuring their physical and emotional safety is a top priority. Some things to watch for are poor personal hygiene, unexplained bruising, bedsores, and personality and mood changes. If you have concerns about the physical and/or emotional safety of your loved one you should contact 911 if they are in imminent danger. You can also contact your Ombudsman at 855-582-6769. They act on behalf of residents to assure their rights are not violated. You can also submit the Nursing Home Complaint Form. under his policy. SUM coverage is extremely important as it protects you if the vehicle that caused the accident does not have a high enough insurance policy to compensate you for your injuries. In this case, the client was represented by Maureen Maney, a partner in our firm. The SUM carrier only offered \$70,000. Our firm fought back by placing the claim into a lawsuit. Maureen was ultimately able to get the matter to proceed to an arbitration. She obtained an award for the client in the amount of \$385,000.
